

NOTES FOR CAPTAINS 2021/22 #1

CAPTAIN'S RESPONSIBILITIES

The nominated captain is the person listed on the original team nomination lodged with the SSCA. A 'stand in captain' assumes the same responsibilities of that captain.

The major responsibility for ensuring fair play rests with the captains, but does extend to all players & match officials.

Captains are responsible for ensuring that matches are played not only according to the Laws, but also in a way consistent with the Preamble of the Laws (the Spirit of Cricket) and will follow the Association's Code of Conduct prescribed at Schedule 1 of the SSCA Playing Conditions.

MyCricket

It is the responsibility of the nominated team captain to ensure that all the requirements for recording & reporting on MyCricket are undertaken (see Notes for Captains 2021 #2 & #3).

It is the responsibility of the nominated team captain to ensure that all necessary access levels on MyCricket are in place to allow any 'stand in captain' to enter required details on MyCricket and that the 'stand in captain' is fully aware of his/her responsibilities.

COVID-19 SAFE

Sutherland Shire Council has advised that Sutherland Council Authorised Officers may monitor community sport restarting. To ensure that all cricket matches are allowed to continue you must comply with the SSC Return to Play 2021-22 Health Order compliance instructions.





- > Compliance documents must be completed <u>no excuses</u>
- A new SSCA Match checklist must be completed for every day you play (i.e. day 1 & day 2 of 2 day matches, and every 1 day match)
- Copies of checklists are to be kept in a safe place and provided to SSC, NSW Health or SSCA authorised representatives when requested
- It is the responsibility of both team Captains to ensure checks are completed and available at the match for inspection
- If teams at a match do not have Compliance documents completed and available if SSC, NSW Health or SSCA authorised representatives ask to see them:
 - (1) all play will immediately be suspended
 - (2) result will be recorded as forfeit by both teams
 - (3) No competition points will be awarded to either team

Over restrictions for young medium / fast bowlers

It is the responsibility of the nominated team captain to ensure that no medium-paced or faster bowler (broadly defined by one or both umpires as one to whom a wicketkeeper would normally stand back) shall be permitted to bowl more than the number of overs in a spell, and number of overs in a day's play as set out below

Age at 31 August	Max. Overs in a Spell	Max. Overs in an Innings	Max. Overs in a Day's Play
Under 19	8	10	20
Under 17	6	10	16
Under 16	6	10	12
Under 15	5	10	10
Under 14	5	10	10

CLARIFICATION: Players age at 31 August 2020 determines maximum overs to be bowled in each match for the entire season..

e.g. A player subject to age restriction is aged 14 on 31/8/2020 & turns 15 on 30/9/2020. The player will be restricted to 5 overs in a spell, 10 overs in an innings & 10 overs in a days play for the entire season.
